We apologise in advance at this long list of conditions but in this age of increased and un-necessary litigation, we feel this is necessary to protect both ourselves as the training provider, but also yourself as the student. Please read these carefully before attending your course.

Here we go, and in no particular order:-

- Payment in full must reach us in 14 days from submitting the on line application form or accompany a printed application form.
- We reserve the right to cancel a course at any time. We will offer you a place on other dates for the same type of course. If this isn't suitable to you we will refund your course fee.
- We undertake our courses in all types of weather and will not offer a refund or a substitute course unless weather conditions are so extreme as to cause a health and safety risk.
- You are responsible for Health & Safety whilst on our courses. We will not be responsible if you do not use the personal protection supplied or bring with you.
- You will need to bring along steel capped shoes/boots or very strong footwear to prevent damage to your feet from falling stone or tools.
- You must have completed a Beginners course, or equivalent, to be eligible for the Improvers course.
- The certificate you will receive at the end of the course is an attendance certificate and not a certificate of competence. We advise that students prove their competence by gaining qualifications via the Dry Stone Walling Association Craftsmanship Scheme which is Lantra
